### **Update from the Finance Department**

Our finance team has been as busy as ever over the last few months. Our new task is to get ready for the upcoming year end audit. The audit is scheduled to start late in May and is expected to be completed by the middle of July. The audit of the Annual Financial Statements from the previous year (2022/2023) was also completed back in November.

The FAC has been working closely with Council and Bingwi Neyaashi Anishinaabek's (BNA) administration. BNA places a strong emphasis on financial transparency and accountability, as well as making preparations to achieve certification through the Financial Management Board (FMB).

Here are a few key items that the FAC and administration has been working on:

*I. Audit Review and Approval:* The FAC is actively involved in the audit review process. They had the opportunity to sit down with MNP and thoroughly review the 2022/2023 audit. This process allowed them to ask questions and provide suggestions for the next year's audit. The audit was subsequently recommended for approval by Chief and Council, and it was approved. This process enhances transparency and ensures financial accountability.

*2. Financial Administration Law (FAL) Update:* As BNA moves closer to certification through the FMB, we have updated our Financial Administration Law (FAL). This updated FAL is necessary to approve amendments from the previous FAL and repeal the 2020 version, ensuring that our financial practices are in compliance with current standards.

3. Preparation for Certification: BNA is actively working with the Financial Management Board (FMB) to complete our certification. This involves reviewing key policies, including Human Resources Policy, Information Management Policy, and Finance Policy, to ensure they align with the requirements for certification. This is a huge milestone for BNA and a lot of hard work has gone into reaching this point. This is an added step to provide BNA with a certification to support our financial accountability practices and will open the door for external partnerships. The certification team attended our office from April 24 - 26 to complete their field work to ensure that BNA is operating in accordance with its policies and the FAL. From there, based on their findings, they will recommend BNA to be certified.

The FAC's actions reflect a strong commitment to sound financial governance and a dedication to ensuring that BNA is well-prepared for certification. The FAC and BNA leadership are working together to ensure financial responsibility and transparency for the benefit of the BNA membership. In the next couple of months, the FAC, along with Council and BNA administration, will be working on completing the planning process for the next fiscal year. This includes budgeting for next fiscal and completing BNA's multi-year financial plan.

Chief and Council, at the recommendation of the Finance and Audit Committee (FAC), met and approved the annual operating budget for the 2024/2025 fiscal year on March 18, 2024. This budget was prepared in collaboration with the program directors and managers as we head into another operating year.

As always, to ensure a smooth and accurate processing of paperwork on our end, we ask that everybody please continue to allow a minimum of two weeks for any payment requests to be processed and paid. Our team continues to process cheques and direct deposit payments every Thursday.

#### New Loan from First Nation Finance Authority

As you will recall, back in June of 2023 the road into the community suffered extensive damage as a result of the spring thaw. This required BNA to invest a significant amount of money to have the road repaired and make it suitable for use. This road construction was performed by Teranorth Construction over a number of months and cost BNA approximately \$2.5 million to complete. At the time, in order to ensure that the road was repaired as quickly as possible, BNA initially paid the repairs solely from cash on hand and from its GIC investment; no external financing was received. These funds needed to be replenished through some form of financing, so in February BNA approached the FNFA and received a loan for the total cost of the project, \$2.5 million. The FNFA is a fully First Nation-governed entity and is run by its borrowing members. Because of the structure of this organization, BNA was able to secure this funding at a much lower interest rate than if it had borrowed from a traditional lender. The FNFA is the only funding source for this project; no other sources of financing were used.

As part of its mandate, ISC is responsible for funding key infrastructure, such as roads. Our infrastructure team has prepared and submitted capital applications to ISC to recover as much of the expenses associated with the road project as possible.

## **Economic Development Updates**

#### Sawmill Expansion: New Planer-Moulder Building

In the summer of 2023, BNA was approved through the Ministry of Indigenous Affairs for a new building study for the BNA Sawmill expansion. This new building is critical to ensure that there will be enough room for the new value-added equipment line, which simply will not fit in the current Sawmill building. However, to get funding support for this building, BNA must prepare the required background material to show the funder that the project is indeed feasible.

Therefore, BNA worked with it's consulting partners at TBT engineering to conduct both geotechnical studies as well as new topographic surveys at the site around the current Sawmill building. This is important to show the amount of material that will need to be brought in to ensure the structural sustainability of the new building. BNA also worked with Northern Community Solutions (NCS) to complete a business plan for the new building. It is critical that the wood flow from the Sawmill operation fits well in the plan, as the planer-moulder stage is the final stage of wood production, after the sawing and kiln drying is complete.

The next step is for BNA to apply to funding agencies to support this important piece of infrastructure.





#### Little Jackfish River Hydro Project Update

BNA has continued to meet with OPG regarding the re-commencement of the Environmental Assessment for this project, which would be nearly 80 MW in size. It would involve the Lake Nipigon First Nations being co-proponents on the Environmental Assessment for the project, and equal equity owners of the site in case it were to move forward to construction. Discussions continue at a preliminary level with OPG and the neighbouring First Nations on this proposed development.

Associated with this Project would be a transmission line capable of transmitting this power to both mining developments and the overall provincial transmissiongrid. This process is a planning exercise with the Independent Electrical Systems Operator (IESO), which analyzes transmission routing, while looking at the major projects and developments occurring in the region. BNA and its neighbouring First Nation communities plan to be at the table for these discussions. Currently, our community is being serviced by the terrible and inadequate A4L transmission line, which has frequent outages for BNA and the Greenstone region. We believe we are in dire need of new transmission in the region, both for the development of our community, but also to enable regional mining, forestry, and other projects throughout the Greenstone region and beyond.

We will continue to update the BNA membership about Little Jackfish and the regional transmission initiatives that are being pursued.

#### **Biomass Project in Hurkett**

On March 13th, Lake Nipigon Forest Management Inc., in which Papasay is a 25% shareholder along with its neighbouring First Nation communities, had its signing ceremony in Hurkett along with our partners, Char Technology. This Project will be taking wood waste and residue from forestry operations throughout the Lake Nipigon and neighbouring Forests, gasifying it and turning it into clean, renewable natural gas, which will supplement dirtier natural gas in the system. The residue, which is called "biochar" will be sent to southern Ontario to supplement coal in the steel plants.

The signing ceremony was attended by the LNFMI Board, Char leadership, Chiefs and Councillors neighbouring communities, from the and representatives from industry and government. This project is a true example of what can happen when communities work together for the betterment of the region, and use best technologies to help to improve the planet. Benefits to the communities will include employment opportunities for members, and revenue generation to assist with the re-building of Sand Point.

The timeline for this project is ambitious. We hope to be in operation by the summer/fall of 2025.

#### **BNA Commercial Zone Study**

In 2023, BNA carried out its Commercial Zone Feasibility Study with TBT Engineering and MNP, and support from Indigenous Services Canada's Community Opportunities Readiness Fund. This involved looking at the feasibility of multiple proposed developments on its reserve lands: a gas bar and convenience store, including electric charging stations and showers for truckers; a hotel and restaurant; and a helipad. This development would take place on the northern-eastern most portion of the BNA reserve, which offers good line of sight for truckers coming in either direction. The study included a new traffic study, development costs, and marketing research, and recommendations for proceeding to the next stage.

The results of the study were mixed. The gas bar, convenience store and helipad were given a positive feasibility outlook. While the hotel and restaurant were not viewed as favourably in the study, more work still needs to be done to ensure that the proper inputs are considered, including looking at changing the scope and size of that development.

BNA has an opportunity to access significant supports from ISC for site development, however cannot move that forward without first having all of the soft studies complete, including business plans for each proposed business. We will continue to work on this development to ensure that BNA is well positioned to take advantage of the multiple projects that will be occurring in the region.



#### Economic Development Updates

#### **MTO Highway Projects**

For many years, BNA has struggled to realize real opportunities with the Ministry of Transportation (MTO) on regional highway projects. However, over the past few months, opportunities for participation have become a reality.

The first was a set-aside opportunity for our First Nation on a culvert replacement between BNA and Beardmore. We supported Teranorth, and along with revenues, we were able to sell aggregates from our Papasay Pit. More recently, an opportunity for set aside culverts has again arisen for work on Hwy 11 heading northeast. Papasay formed a 50/50 company with Rocky Bay First Nation called "2-Nations Construction LP" and are prepared for the upcoming opportunities for 3 culvert replacements. We will again be working with Teranorth for this work. 2-Nations construction will also be working with our neighbouring communities of AZA, Aroland and Ginoogaming and their "Minodahmun" corporation, and will work together for the larger culvert contract. This will be competitive however, so opportunities for revenue generation may be more limited.

Closer to home, through its Title negotiations BNA continues to fight for the Orient Bay #20 Aggregate Quarry near the community and will continue to find a way to open up the on-reserve aggregate opportunity in its Industrial Park.



#### BNA Tourism Study

Last summer, BNA commenced a regional tourism study with NCS, focused on its two Papasay properties: Blue Lake and Big Virgin Island. Blue Lake was purchased over a decade ago, and has an old sauna, pergola, and aggregate material on-site. While this property provided the majority of the materials currently making up Lot A of the BNA Industrial Park, we were hoping to utilize the property as an income generator. Unfortunately, the results from the study were not great. Greenstone Gold Mines did not show an interest in the site as a rental, and feasibility-wise it is not a major revenue generator. However there could be opportunities for partnering with other tourism operators in the region to make a go at a small operation. This would also get BNA's "feet wet" in the tourism industry regionally.

Big Virgin Island was just purchased a few years ago, and the study looked at opportunities for tourism. Based on the completed study, the best opportunities for development on Big Virgin currently is related to programming for the Family Well-Being department. This would ensure that infrastructure is developed on the island. Through this study, the co-management of the north and south ends of the island was also explored, which would involve discussions with the province to put in nature trails or other additions that would assist with tourism in the future.

The study also talked about a local option, something small on-reserve that could both bring revenues into the community, as well as prepare BNA and its members for the future, large-scale tourism opportunities that will come with the building of our eco-lodge when we get our new lands. This could be fully funded, ensuring the community is not out of pocket for development dollars. BNA will explore these options further as part of our overall regional development.

Lawrence is survived by his daughters Kari Esquega, Selena Esquega, and his son Karhu Esquega, his sisters Lucy Day, Theresa Esquega and Myria Esquega, his numerous nieces and nephews, great nieces and nephews and his 9 grandchildren and 1 great granddaughter.

Lawrence was predeceased by both his parents Margaret and Victor Esquega, his brothers Victor Esquega, Edward Esquega Sr and Quincy Esquega, and special sister Irene Harper, his nephews Gene Esquega, Edward (Eddie) Esquega Jr, Craig Johnston, Nicky Bannon and Tommy Bannon.

Lawrence was a Councillor and beloved Elder for Bingwi Neyaashi Anishinaabek formerly, Sand Point First Nation. Lawrence loved learning about his Culture, Traditions and Anishinaabemowin. Lawrence participated regularly at BNA events over the years, providing advice, wisdom, and guidance to both staff and leadership. This included sharing his knowledge and history of the area around Sand Point in Elder interviews. This allowed BNA the opportunity to properly document its traditional territory, which has been vital to our work in the land claim negotiations. His humour and wit was always welcomed.

Lawrence worked on the ships for many, many years, and he loved being around his family, he enjoyed his music and playing the guitar. Lawrence always portrayed a smile and had a contagious laugh. Most of all, he was great father and grandad who will be sorely missed by his family and friends.

Private viewing services were held at Blake's Funeral Chapel on Monday April 29, 2024, for family and close friends. His immediate family will be taking his ashes to Bingwi Neyaashi Anishinaabek where they plan to hold a small, intimate gathering at his final resting place.

#### R.I.P. Frank ("Tunny") Hardy

January 14, 1964 - March 19, 2024



BNA sends its best wishes to Peggy and the community of BZA on the loss of Tunny. Tunny was a long-time employee at BZA, working in the lands and resources areas. The Chief, Jordan and others in the BNA office worked very closely with Tunny on joint projects in the region. These included the Little Jackfish Hydro Development, the Axor Hydro project, mining and exploration work, Lake Nipigon Forest Management and biomass initiatives, Hwy developments, and joint conservation and sustainability work.

Always hard working and diligent, Tunny brought his experiences from living and working on Lake Nipigon his whole life to the table. In the process, he made us better at our jobs, ensuring that we never forgot about the importance of the environment whenever we worked with industry. Tunny will be missed.



## **Community Energy Coordinator**

Hello and Happy Spring from BNA's Community Energy Coordinator. Below is the list of energy projects we have been working on:

#### **Transmission Line Projects**

All transmission line projects within the community have been completed (Copper Thunderbird, Middle Beach, Phase 4 housing Area, and Phase 1 Housing Loop). We are continuing to work with the Indigenous representative from Hydro One on when they will take over the transmission lines.



#### District Biomass Heating System Project

BNA and TBT Engineering have completed the design for the construction proposals for the District Biomass Heating project. We have sent in several proposals to several funding agencies for this work and waiting for approval. The geotechnical and site clearing have been completed as well as all feasibility studies. The project consists of using one small and one big boiler to provide heat for a large portion of the BNA community. The distribution lines will be buried underground and can last for approximately 30 years. The district biomass heating system is a clean and reliable way to heat homes.



#### Food Sovereignty Sea-Can

BNA was recently successful in receiving funding for installation of a Sea-Can to clean and store traditional food such as moose meat, fish, etc. Equipment inside the Sea-Can will consist of folding tables, tabletop ice machines, shelving, a smoker, and vacuum sealing bags. The installation of the Sea-Can has an expected completion date of August 31st, 2024. All equipment has been purchased, and we are waiting on Sea-Can delivery.

#### **BNA Ice Making Shack**

BNA was successful on getting funding for the construction of a ice shack on the land. This will provide fast and fresh ice to keep fish quality for longer periods of time. The construction has an estimated completion date of July 31st, 2024.

#### Energy Savings Tip

**Open your windows.** Opening windows creates a cross breeze, allowing you to naturally cool your home without switching on air conditioners. This is an ideal approach in spring when temperatures are mild.



### **Housing & Infrastructure**



**BNA 2024 CMHC Section 95 Housing** CMHC Section 95 serves as a pivotal program in facilitating access to housing for First Nations communities across Canada. Through this initiative, eligible entities, such as BNA, have the opportunity to apply for housing units to meet the pressing needs of community members. Typically, BNA submits applications for a specific number of units, aiming to provide stable and suitable accommodation options. If approved by the funder, CMHC, BNA's housing administration will issue notifications to the community, informing of the opportunity to reside in these units under a rent-toown arrangement. It's worth noting that all CMHC Section 95 units operate under 15-year agreements between BNA and CMHC. This agreement structure ensures a long-term commitment between BNA and community members/tenants eventually having the option to transition from renting to ownership at the end of the agreed-upon period. Overall, CMHC Section 95 stands as a vital mechanism in fostering housing security and empowerment within Indigenous communities, emphasizing sustainability and community engagement in the housing process.

#### CMHC Housing Internship for Indigenous Youth

BNA's decision to apply for the Housing Internship for Indigenous Youth program offered by CMHC demonstrates a commitment to nurturing talent within BNA community and supporting youth development. The program targets Indigenous youth aged 15 to 30, offering valuable work experience and training opportunities in various aspects of housing administration, maintenance, construction, renovation, tenant relations, and related areas. BNA, acting as a sponsor, will play a crucial role in providing on-the-job training, coaching, mentoring, and support for skills development and technical training to the selected interns. It's important to note that interns must not be otherwise employed or receiving Employment Insurance benefits during the internship period, ensuring a focus on skill enhancement and career advancement. By participating in this program, BNA contributes to building a skilled workforce and empowering BNA Indigenous youth to pursue meaningful careers in the housing sector.

#### First Nations Market Housing Fund



#### and BNA

In late fall of 2023, BNA conducted outreach through an Expression of Interest within the community members to assess interest in participating in the First Nations Market Housing Fund program, and the response was high. Working closely with the Fund, BNA is dedicated to fostering the capacity within the community to establish and sustain loan-based housing initiatives. This endeavor aims to enhance social welfare, spur economic development, and bolster civic improvement across the community and for the community residents. With strategic foresight, BNA identified and allocated six lots, each 0.25 hectares in size and situated along the shoreline of Lake Nipigon. As BNA progresses through the program, the community will be kept informed and engaged, particularly as the next phases unfold, including the acceptance of applications for BNA housing and financial lender partnerships, and ultimately, the allotment of lots to successful applicants. This transparent and inclusive approach underscores BNA's commitment to empowering its community members and fostering sustainable housing solutions that positively impact their lives.

## **Governance Coordinator Update**

Boozhoo my fellow band members. It has been a busy year in the governance coordinator department. I have completed Bingwi Neyaashi Anishinaabek's Onboarding Manual for Council. This is a proactive step towards ensuring smooth transitions and effective governance within Bingwi Neyaashi Anishinaabek. It shows a commitment to transparency, efficiency, and supporting your Council members in their roles and responsibilities. This Onboarding Manual has been officially implemented on April 1, 2024.



#### BNA – Papasay Cooperation Agreement

A proposal for a Cooperation Agreement between BNA and Papasay (including Ratification) has been submitted to and approved by the Professional and Institutional Development (P&ID) through Indigenous Services Canada (ISC). This Cooperation Agreement demonstrates a proactive approach to fostering partnerships and collaboration. It will be completed throughout this fiscal year.



#### Wills and Estates

Bingwi Neyaashi Anishinaabek has been approved to have 30 members take part in having their Wills or Power of Attorney (POA) or Power of Care (POC) done. We will have an attorney come in from Edwards Bell Jewitt LLP to meet individually with our members who have expressed interest in having their Wills, POA's or POC's completed. The first meeting with an attorney would be to gather relevant information like marital status, child(ren), grandchild(ren), assets. liabilities. intended executor and beneficiaries. A second meeting with the attorney may be required if there is any missing information, the attorney will then draft up the Will, POA, or POC. Further information will be sent out to those members who have signed up for this and I will personally reach out to you once we near the date. Please note that it is especially important for those members residing in Sand Point to complete their wills.

The CCP is a guide for leadership, staff, and managers to stay on track to the community's overall vision. All staff will be given a copy of the CCP to ensure they can follow our priority actions and will use as a frame of reference for developing any new plans going forward such as the Land Use Plan, Economic Development Plan, ect. Alongside that, as the CCP Coordinator, Jake will be working with the staff to follow-up on any priority action items throughout the year.

As a community member, you will receive a CCP package in the mail that summarizes all the

important information listed in the CCP. Any important or substantial updates will be noted in our quarterly newsletters and there will be annual updates for all CCP changes and successes at our Annual General Meetings. The plan will not change long-term, but every 5 years we will re-look at the CCP and see if Action Items need to be revised and moved to the appendix.

#### Digital Heritage Project

We are pleased to announce the completion of the Digital Heritage Project, also known as the Reclaiming our History Project. This has been a year-long project with assistance from CE Strategies where we have been collecting photos, stories, and videos of Sand Point members and their families to store securely. This is incredibly important to record and keep for future generations to be able to access.

Over the past season we have provided wider range of cultural enrichment activities, such as regalia making, drumming sessions, and traditional workshops. We had our Youth Bingo Night at Van Norman, making it available to youth members online who live on the land or out of the city. We had lots of great prizes to be won and many came out to join. In February, we got our Youth and Juniors together for a fun evening on the hill, tubing at Mount Baldy. Everyone always enjoys this event as it adds a little thrill to our program. It was nice to see the two groups interacting with each other and getting to know each other better. We started a third group this month. An Adult Youth Night where we brought out our Adult Youth (Age 18-29) to Wacky Wings for a night of food and games. It was a good turn out and we had a lot of positive feedback from these young people about being able to go out together. We will continue with our Adult Youth nights this new year due to the awesome turn out and feedback.

In March we had our Youth come out for two cooking classes with Roots to Harvest. There they got to learn how to make chicken fettuccine alfredo from scratch, as well as pasta noodles and spaghetti sauce. They Learned basic food handling skills, how to cook meat, use knives and the importance of clean workstations. At the end of the evening, they enjoyed their homemade meal together and it was such a delicious meal. March Break Events were a huge success. It kicked off with our Annual Fishing derby out on the land, we had many members come out and spend time on Lake Nipigon. They fished for speckle trout, lake trout, white fish and more. We had a Fishing Net Demonstration and managed to catch a few different species in the net. The wind was very fast, and the weather was cold on the first day, but the second day was much warmer. It was awesome to see that many showed up for both days. Watching our Youth try out different

parts of the lake attempting to get that big fish was a highlight for sure. Everyone spent time fishing and socializing with each other while eating great food and listening to the sounds of the ice sing. There were only two fish caught on rods the whole derby, but we had fun regardless.

The rest of the week was filled with fun activities such as a Family Movie Matinee where we went to see Kung Fu Panda 4. This was a back up plan from cross country skiing which couldn't happen, followed by a family tubing day at Mount Baldy. To top it all off had our "winter" carnival out at Grandview, where we had Boreal Journeys bring their sled dogs and people were taught how to harness the dogs and drive the sled while getting to interact with the dogs and pups. ### **Introducing Aandeg Skelly: Community Volunteer**



As my name is showing up on more BNA documents, I thought it was time I introduced myself. I am Aandeg Miigwan Skelly.

I started the band's genealogical and historical research in 2005. In 2012 I reviewed the Sand Point Historical Files, and in 2017 I was asked if I could volunteer full time for BNA as Researcher, Genealogist & Family Historian. Since then, I have continued to assist with work on our Title Negotiations and in 2017 became actively involved in the Robinson Superior Annuity Case - reviewing all Expert Witness Reports, attending court every day through Stages 1 and 3 while housing and organizing all documents generated through the trial. Since 2021 I have continued assisting with work on the Framework Agreement and the Annuity Case and have also worked with staff on various projects including Norval Morrisseau Project; Cemetery Project; Community Photo Album (Digital Heritage Project); BNA Vision Statement; Repatriation of Artifacts; Digital Archives Project, and more.

At this point I must inform the members that I was firm that I did not want to receive a salary, but would prefer to see the money go to band programming. I was able to do this due to the support from my wonderful husband Marcel Donio.

I have written several articles for BNA: Sand Point's Historical Timeline; 9 Identified Dodems of Lake Nipigon; Understanding Treaty Annuity Pay Lists; Census Sources Explained; McIntyre Bay History and Timeline; Colonial Interference of Band Population; Theft of Land – Historical Fiction – Death and Rebirth of a Cemetery; Understanding The Robinson Superior Treaty; History of the Canadian National Railway – Kinghorn Line.

When time allows between transcribing the Lake Nipigon Hudson's Bay Journals 1792 – 1897 and the Indian Affairs Treaty Annuity Lists 1850-1950, it has been my pleasure to assist members and staff with their genealogical history. It has also been a privilege over the years to successfully obtain (at no charge) Indian Status or Métis Status for over 500 people. Work is ongoing regarding the inequities for individuals due to the Indian Act, such as Bill C38 regarding the expansion of Enfranchisement limitations, plus revising the 'Two Generation' cut off.
